As the author of a monography/the editor of an edited volume, I undertake to pay the University Library EUR 300,00 plus VAT per issue (for multi-volume works: per volume) in the case of publication by means of print-on-demand (POD) in order to participate in the production costs. This obligation does not apply to authors of contributions.

In accordance with legal provisions, the University Library is entitled to grant simple rights of use to supraregional long-term archiving systems (German National Library, Baden State Library) without requiring my separate special permission.

I hereby assure that I am legally entitled to dispose of the copyright of the work and any third-party texts and/or images contained therein, and that I have not previously made any dispositions that conflict with the rights granted by this declaration, so that no legal provisions and no rights of third parties are violated. I shall inform the University Library immediately of all texts, images, graphics, illustrations, etc. to which I have no rights, the use of which I am not entitled to dispose of without restriction or whose (copyright) status is uncertain. I shall indemnify the University Library in full against all claims by third parties, including the (costs of) legal prosecution and/or legal defence.

I hereby assure that I have independently created this work in accordance with generally recognised scientific principles.
